

Lianhe Global Participated in “2021 China Conference” held by BofA Securities

On 4 November 2021, the “2021 China Conference” organized by BofA Securities was held virtually. In this 10-day event, Dr. Stan Ho, the Chief Executive Officer of Lianhe Global, participated in the “China onshore/ offshore bond market: the diverging trend from a rating/ default perspective” roundtable discussion with Ivan Chung, Associate Managing Director, Corporate Finance Group, Moody’s investors Service Hong Kong, and moderated by Joyce Liang, Head of Asia Pacific Credit Research and Asia Credit Strategist, BofA Global Research.

As the representative of the largest Chinese offshore credit rating agency during the roundtable discussion, Dr. Stan Ho shared his opinions on the current situation of the Chinese property bond issuers, the factors used to differentiate property issuers, Chinese property offshore bond market outlook, observed changes of the rating process for local government financing vehicles during the COVID-19 pandemic, trends for the credit fundamentals across sectors and the default rate for the Chinese property sector.
