

Appointment of Lianhe Global CEO as a Panel Member for the Subject Advisory Panel of Certified Banker Programme under HKIB

Dr. Stan Ho, the Chief Executive Officer of Lianhe Ratings Global Limited, was appointed as a panel member for the Subject Advisory Panel (“SAP”) of Certified Banker Programme under the Hong Kong Institute of Bankers (“HKIB”) effective 1 March 2022.

The HKIB, established in 1963, is the first not-for-profit institution that provides training and certification services to the banking community in Hong Kong and is the first professional body in the territory to offer banking qualifications equivalent to a Master’s degree level. It aims to develop a strong community of banking professionals across different territories and help set professional standards for the banking industry across the region. Currently, Its designated professional qualifications are widely recognized both in Hong Kong and overseas. In 2020, its individual members reached over 10,000 with over 80% of them being Professional Members.

The SAP provides recommendations to the Certified Banker Steering Committee (“CBSC”) on module development and enhancement. The main role of a panel member is to provide comments on the training and examination/assessment materials and the methodologies in accordance with current and future training/development needs, and industry standards as well as different regulatory policies and initiatives.
