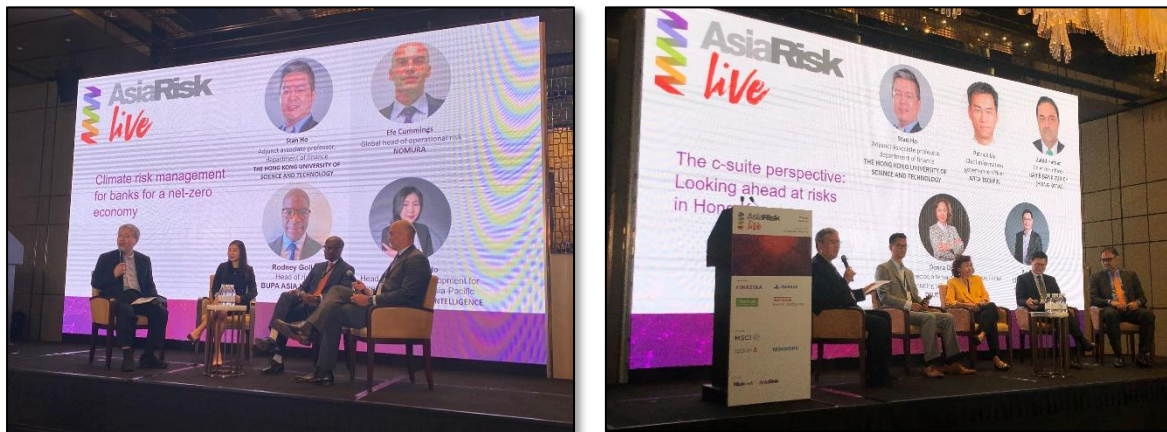


Lianhe Global Participated in “Asia Risk Live 2022”

On 5 October 2022, Lianhe Ratings Global Limited (“Lianhe Global”) participated in the “Asia Risk Live 2022” organized by Risk.net. In the morning session on the first day of this 2-day in-person event, Dr. Stan Ho, the Chief Executive Officer of Lianhe Global, participated as a moderator in 2 panel discussions: “Climate Risk management for banks for a net-zero economy” and “The C-Suite Perspective: Looking ahead on risks in Hong Kong”. This morning session attracted around 150 market participants.



In the first panel, Stan asked the panelists about the implementation of regulatory requirements to address climate risk, how to build climate risk framework, the role of stress testing and scenario analysis in climate risk management and how to align climate risk exposure with risk appetite and business and credit strategy. In the second panel, Stan invited the panelists to share their views on the lasting impacts of COVID-19 on Hong Kong financial markets, the focused priority by the Hong Kong Monetary Authority on the climate risk agenda, and the talent risks in Hong Kong etc.
