

## **Lianhe Global has assigned ‘BBB+’ global scale Long-term Issuance Credit Rating to Taixing City Investment Development Group Co., Ltd.’s proposed CNY Bonds**

HONG KONG, 18 April 2024 – Lianhe Ratings Global Limited (“Lianhe Global”), an international credit rating company, has assigned ‘BBB+’ global scale Long-term Issuance Credit Rating to the senior unsecured CNY Bonds (“the Bonds”) to be issued by Taixing City Investment Development Group Co., Ltd. (“TCID”; ‘BBB+/Stable’).

TCID intends to use the net proceeds from this offering for project development and supplement of working capital.

### **Key Rating Rationales**

The Bonds are rated at the same level as TCID’s global scale Long-term Issuer Credit Rating of ‘BBB+’ as the Bonds constitute direct, unconditional, unsubordinated and unsecured obligations of TCID. The payment obligations of TCID under the Bonds shall at all times rank at least equally with all its other present and future unsecured and unsubordinated obligations.

The Issuer Credit Rating reflects a high possibility that the People’s Government of Taixing City (“Taixing government”) would provide very strong support to TCID if needed, in light of its full ownership of TCID, TCID’s strategic importance as a core local investment and development company in Taixing, and the linkage between the Taixing government and TCID, including appointment of the senior management, strategic alignment, supervision of major financing plan and investment decisions and ongoing operational and financial support. In addition, the Taixing government may face significant negative impact on its reputation and financing activities if TCID encounters any operational and financial difficulties.

The Stable Outlook on TCID’s rating reflects our expectation that TCID’s strategic importance would remain intact while the Taixing government will continue to ensure TCID’s stable operation.

### **Rating Sensitivities**

Any rating action on TCID’s rating would result in a similar rating action on the Bonds.

We would consider downgrading TCID’s rating if (1) there is perceived weakening in support from the Taixing government, particularly due to its reduced strategic importance with diminished government functions, or (2) there is a significant reduction of the Taixing government’s ownership of TCID, or (3) there is a downgrade in our internal credit assessment on the Taixing government.

We would consider upgrading TCID's rating if there is an upgrade in our internal credit assessment on the Taixing government.
