

Lianhe Global has affirmed 'BBB' global scale Long-term Issuer and Issuance Credit Rating of Shandong Mingshui Guokai Development Group Co., Ltd.; Issuer Rating Outlook is Stable.

HONG KONG, 06 November 2025 – Lianhe Ratings Global Limited ("Lianhe Global"), an international credit rating company, has affirmed 'BBB' global scale Long-term Issuer Credit Rating of Shandong Mingshui Guokai Development Group Co., Ltd. ("SMGD" or "the company"); Issuer Rating Outlook is Stable.

Lianhe Global has also affirmed 'BBB' global scale Long-term Issuance Credit Rating of senior unsecured bonds issued by SMGD at the same timer. A full list of affirmed issuance rating is included in this press release.

Key Rating Rationales

The Issuer Credit Rating reflects a high possibility that the People's Government of Zhangqiu District ("Zhangqiu government") would provide strong support to SMGD if needed. This mainly considers the management committee of Mingshui Economic and Technological Development Zone ("Mingshui ETDZ"), a local office of the Zhangqiu government, indirectly owns SMGD's majority ownership and the company's strategic importance as the most important development and operation platform for Mingshui ETDZ. The linkage between the local government and SMGD is strong, including management supervision, strategic alignment and ongoing operational and financial support. In addition, the local government may face significant negative impact on its reputation and financing activities if SMGD encounters any operational and financial difficulties.

Zhangqiu is a municipal district of Jinan, the capital city of Shandong Province. Zhangqiu's GDP grew steadily by 6% to RMB130.1 billion in 2024, while the budgetary revenue grew slightly by 1.3% to RMB6.1 billion. Mingshui ETDZ is a national-level development zone in Zhangqiu.

The Stable Outlook reflects our expectation that SMGD's strategic importance would remain intact while the local government will continue to ensure SMGD's stable operation.

Rating Sensitivities

We would consider downgrading SMGD's rating if (1) there is perceived weakening in support from the local government, particularly due to its reduced strategic importance, or (2) there is a significant reduction of the local government's ownership of SMGD, or (3) there is a downgrade in our internal credit assessment on the Zhangqiu government.

We would consider upgrading SMGD's rating if (1) there is strengthened support from the local government, or (2) there is an upgrade in our internal credit assessment on the Zhangqiu government.

Any rating action on SMGD's rating would result in a similar rating action on its senior unsecured bonds.
