

Lianhe Global has upgraded the global scale Long-term Issuer Credit Rating of China Great Wall Asset Management Co., Ltd. to 'AA' from 'AA-'; Outlook Revised to Stable

HONG KONG, 9 May 2026 – Lianhe Ratings Global Limited (“Lianhe Global”), an international credit rating company, has upgraded the global scale Long-term Issuer Credit Rating of China Great Wall Asset Management Co., Ltd. (“China Great Wall”) to ‘AA’ from ‘AA-’. The Issuer rating is revised to Stable from Positive.

Key Rating Rationales

The Issuer Rating upgrade reflects an upgrade in our internal credit assessment on the Chinese government and the expectation of continuing of a high possibility that China Great Wall would receive strong government support if needed, considering its strategic importance in maintaining economic and financial system stability in China as a national financial assets management company and its state ownership with close management supervision. The company is focusing on its core distressed-asset management business and remains profitable.

China Great Wall is one of five national AMCs and one of twenty-six central financial enterprises in China. Following the equity transfer and capital increase in 2025, Central Huijin Investment Ltd., a wholly state-owned investment company that exercises the state’s shareholder rights in major financial institutions on behalf of the Chinese government, became China Great Wall’s controlling shareholder. The company’s capital position improved materially after the RMB36.8 billion capital injection, strengthening the capacity to perform its policy role. It proactively supports the risk resolution among small and medium-sized financial institutions, local government debt-related areas and the property sector.

The Stable Outlook reflects our expectation that China Great Wall’s strategic importance would remain intact, and the company will maintain its stable operation with government support.

Rating Sensitivities

We would consider downgrading China Great Wall’s rating if (1) there is perceived weakening in support from the Chinese government, particularly due to its reduced strategic importance, or (2) there is a significant reduction of state ownership in the company, or (3) there is a downgrade in our internal credit assessment on the Chinese government.

We would consider upgrading China Great Wall’s rating if (1) there is strengthened support from the Chinese government, or (2) there is an upgrade in our internal credit assessment on the Chinese government.

Any rating action on China Great Wall's rating would result in a similar rating action on the USD notes.
